

CONTRACT AGREEMENT

THIS AGREEMENT, made this _____ day of MAY 24 2024 between the **ILOILO SCIENCE AND TECHNOLOGY UNIVERSITY**, a public institution of higher learning, organized and existing under Republic Act No. 10595, with office address at Burgos Street, La Paz, Iloilo City, Philippines, represented herein by **DR. GABRIEL M. SALISTRE, JR.**, in his capacity as SUC President III (hereinafter called the "ISAT U") and **ARMIX COPIER RENTALS SERVICES AND SALES** with office address at Phil-Am Compound, Commission Civil Street, Jaro, Iloilo City, Philippines represented by its Proprietor/General Manager, **MR. ARMAN P. PADERNAL** (hereinafter referred to as the "SUPPLIER");

WHEREAS, **ISAT U** invited Bids for certain goods and ancillary services, particularly the **PROCUREMENT OF CUSTOMIZED DIPLOMA JACKET FOR REGISTRAR** with Project Reference No. ISAT U GOODS – 2024 – 02 – 039 and has accepted a Bid by the **SUPPLIER** in the sum of **ONE MILLION THREE HUNDRED NINETY FIVE THOUSAND THREE HUNDRED SIXTY PESOS ONLY (PhP 1,395,360.00) ONLY**, hereinafter called the "Contract Price".

In consideration for the sum of **ONE MILLION THREE HUNDRED NINETY FIVE THOUSAND THREE HUNDRED SIXTY PESOS ONLY (PhP 1,395,360.00) ONLY** or such other sums as may be ascertained, **ARMIX COPIER RENTALS SERVICES AND SALES** agrees to supply and deliver **CUSTOMIZED DIPLOMA JACKET FOR REGISTRAR** in accordance with his/her/its Bid.
4. The **ILOILO SCIENCE AND TECHNOLOGY UNIVERSITY** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
