

CONTRACT AGREEMENT

THIS AGREEMENT, made this 18 JUN 2024 day of _____ between the **ILOILO SCIENCE AND TECHNOLOGY UNIVERSITY**, a public institution of higher learning, organized and existing under Republic Act No. 10595, with office address at Burgos Street, La Paz, Iloilo City, Philippines, represented herein by **DR. GABRIEL M. SALISTRE, JR.**, in his capacity as SUC President III (hereinafter called the "ISAT U") and **B-SHINE PHARMA** with office address at Anacleto Bldg., Corner Magdalo – Burgos Street, La Paz, Iloilo City, Philippines represented by its Owner, **MR. NOEL D. LACHICA** (hereinafter referred to as the "SUPPLIER");

WHEREAS, **ISAT U** invited Bids for certain goods and ancillary services, particularly the **PROCUREMENT OF DENTAL SUPPLIES FOR OSAS** with Project Reference No. ISAT U GOODS – 2024 – 02 – 030 and has accepted a Bid by the **SUPPLIER** in the sum of **THREE HUNDRED EIGHTY SEVEN THOUSAND ONE HUNDRED SEVENTY TWO PESOS AND NINETY FIVE CENTAVOS (PhP 387,172.95) ONLY**, hereinafter called the "Contract Price".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to;

Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of **THREE HUNDRED EIGHTY SEVEN THOUSAND ONE HUNDRED SEVENTY TWO PESOS AND NINETY FIVE CENTAVOS (PhP 387,172.95) ONLY** or such other sums as may be ascertained, the **B-SHINE PHARMA** agrees to supply and deliver **VARIOUS DENTAL SUPPLIES FOR OSAS** in accordance with his/her/its Bid.
4. The **ILOILO SCIENCE AND TECHNOLOGY UNIVERSITY** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


