

**CONTRACT AGREEMENT**

THIS AGREEMENT, made this JUL 04 2024 day of \_\_\_\_\_, between the **ILOILO SCIENCE AND TECHNOLOGY UNIVERSITY**, a public institution of higher learning, organized and existing under Republic Act No. 10595, with office address at Burgos Street, La Paz, Iloilo City, Philippines, represented herein by **DR. GABRIEL M. SALISTRE, JR.**, in his capacity as SUC President III (hereinafter called the "ISAT U") and **LIBTECH SOURCE PHILIPPINES INC.** with office address at Unit 3 2<sup>nd</sup> Flr. Eight One Eight Building Arnaiz Rd., San Lorenzo Village, Makati City, Philippines represented by its Finance and Administrative Manager, **MS. AMY SABLAON-MAGO** (hereinafter referred to as the "SUPPLIER");


