

CONTRACT AGREEMENT

THIS AGREEMENT, made this 29 day of JUL 2024 between the **ILOILO SCIENCE AND TECHNOLOGY UNIVERSITY**, a public institution of higher learning, organized and existing under Republic Act No. 10595, with office address at Burgos Street, La Paz, Iloilo City, Philippines, represented herein by **DR. GABRIEL M. SALISTRE, JR.**, in his capacity as SUC President III (hereinafter called the "ISAT U") and **PROGRESS HOME AND OFFICE FURNISHINGS** with office address at #10 Lopez Jaena St., La Paz, Iloilo City, Philippines represented by its Authorized Representative, **MR. WILMAR L. LIRASAN** (hereinafter referred to as the "SUPPLIER");

WHEREAS, **ISAT U** invited Bids for certain goods and ancillary services, particularly the **PROCUREMENT OF FURNITURE FOR FOOD TECHNOLOGY** with Project Reference No. ISAT U GOODS - 2024 - 03 - 047 and has accepted a Bid by the **SUPPLIER** in the sum of **ONE HUNDRED THIRTY ONE THOUSAND EIGHT HUNDRED PESOS (PhP 131,800.00) ONLY**, hereinafter called the "Contract Price".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

In consideration for the sum of **ONE HUNDRED THIRTY ONE THOUSAND EIGHT HUNDRED PESOS (PhP 131,800.00) ONLY** or such other sums as may be ascertained, the **PROGRESS HOME AND OFFICE FURNISHINGS** agrees to supply and deliver various **FURNITURE FOR FOOD TECHNOLOGY** in accordance with his/her/its Bid.

4. The **ILOILO SCIENCE AND TECHNOLOGY UNIVERSITY** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.




