

**CONTRACT AGREEMENT**

THIS AGREEMENT, made this \_\_\_\_\_ day of \_\_\_\_\_, \_\_\_\_\_ between the **ILOILO SCIENCE AND TECHNOLOGY UNIVERSITY**, a public institution of higher learning, organized and existing under Republic Act No. 10595, with office address at Burgos Street, La Paz, Iloilo City, Philippines, represented herein by **DR. GABRIEL M. SALISTRE, JR.**, in his capacity as SUC President III (hereinafter called the "ISAT U") and **COMPUTRON BUSINESS CENTER** with office address at 35 Quezon St., Iloilo City, Philippines represented by its Authorized Representative, **MS. VALERIE JINNY ONG** (hereinafter referred to as the "SUPPLIER");

WHEREAS, **ISAT U** invited Bids for certain goods and ancillary services, particularly the **PROCUREMENT OF DESKTOP COMPUTER FOR LIBRARY** with Project Reference No. ISAT U GOODS – 2024 – 03 – 048 and has accepted a Bid by the **SUPPLIER** in the sum of **TWO HUNDRED FIFTY ONE THOUSAND TWO HUNDRED TWENTY FIVE PESOS (PhP 251,225.00) ONLY**, hereinafter called the "Contract Price".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

3. In consideration for the sum of **TWO HUNDRED FIFTY ONE THOUSAND TWO HUNDRED TWENTY FIVE PESOS (PhP 251,225.00) ONLY** or such other sums as may be ascertained, the **COMPUTRON BUSINESS CENTER** agrees to supply and deliver **DESKTOP COMPUTER FOR LIBRARY** in accordance with his/her/its Bid.

4. The **ILOILO SCIENCE AND TECHNOLOGY UNIVERSITY** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


