

**CONTRACT AGREEMENT**

GABRIEL M. SALISTRE, JR.**, in his capacity as SUC President III (hereinafter called the "ISAT U") and **MICROGENESIS BUSINESS SYSTEM** with office address at Unit 1202, Paragon Plaza Bldg., 162 EDSA Corner Reliance Street, Mandaluyong City, Metro Manila, Philippines represented by its Authorized Representative, **MS. MARY JOY E. RICONALLA** (hereinafter referred to as the "SUPPLIER");

WHEREAS, **ISAT U** invited Bids for certain goods and ancillary services, particularly the **PROCUREMENT OF DESKTOP COMPUTER FOR COMPUTER DEPARTMENT** with Project Reference No. ISAT U GOODS – 2024 – 01 – 021 and has accepted a Bid by the **SUPPLIER** in the sum of **SIX MILLION TWO HUNDRED NINETY FIVE THOUSAND SEVEN HUNDRED FIFTY PESOS (PhP 6,295,750.00) ONLY**, hereinafter called the "Contract Price".

4. The **ILOILO SCIENCE AND TECHNOLOGY UNIVERSITY** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
