WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the PROCUREMENT OF CUSTOMIZED DIPLOMA JACKET FOR REGISTRAR on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with the total Approved Budget for the Contract (ABC) of One Million Four Hundred Thirty Five Thousand Five Hundred Pesos Only (PhP 1,435,500.00) inclusive of applicable taxes, "short of award";

WHEREAS, a Pre-Bid Conference was held on March 26, 2024 with five (5) prospective bidders in attendance, namely;

5. Iloilo Printing & Services

WHEREAS, during the scheduled date for the selling of Bid Documents on April 1-9, 2024, One (1) interested bidder availed the official bidding documents in the amount of One Thousand Five Hundred Pesos Only (PhP 1,500.00), namely;
