A RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO CHARLES OFFICE AND SCHOOL SUPPLIES FOR THE PROCUREMENT OF ATHLETIC SUPPLIES FOR PE AND SPORTS AFFAIRS

WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the PROCUREMENT OF ATHLETIC SUPPLIES FOR PE AND SPORTS AFFAIRS on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with the total Approved Budget for the Contract (ABC) of One Million One Hundred Six Thousand Four Hundred Thirty Eight Pesos Only (PhP 1,106,438.00) inclusive of applicable taxes;

WHEREAS, a Pre-Bid Conference was held on March 26, 2024 with two (2) prospective bidders in attendance, namely;

1. King Ken B. Holdings
2. Armix Copier Rentals Services and Sales

WHEREAS, during the scheduled date for the selling of Bid Documents on April 1-9, 2024, Three (3) interested bidders availed the official bidding documents in the amount of One Thousand Three Hundred Pesos Only (PhP 1,300.00), namely;

1. Charles Office and School Supplies
2. King Ken B. Holdings
3. Bacolod Elkan Trading, Inc.

WHEREAS, One (1) bidder submitted a bid proposal within the deadline set on April 10, 2024 at 5pm, namely;

1. Charles Office and School Supplies

WHEREAS, during the bid opening held last April 11, 2024, the BAC reviewed the eligibility, technical and financial envelopes of each prospective bidders using the "pass/fail" criteria as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184, with the following results;

To declare that CHARLES OFFICE AND SCHOOL SUPPLIES as the Single Calculated and Responsive Bid (SCRB) for the PROCUREMENT OF ATHLETIC SUPPLIES FOR PE AND SPORTS AFFAIRS and awarded the contract in the total amount Eight Hundred Fifty Six Thousand Eight Hundred Twenty Four Pesos and Forty Centavos Only (PhP 856,824.40) inclusive of applicable taxes; and
- b. To recommend for approval of the University President the foregoing findings.
