**A RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO B-SHINE PHARMA FOR THE PROCUREMENT OF MEDICAL SUPPLIES FOR MEDICAL CLINIC
 Project Reference No. ISAT U GOODS 2024-03-052**

WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the PROCUREMENT OF MEDICAL SUPPLIES FOR MEDICAL CLINIC on the website of the Philippine Government Electronic Procurement System (PhilGEPs), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with the total Approved Budget for the Contract (ABC) of Eight Hundred Fifty Two Thousand Three Hundred Fifty Five Pesos Only (PhP 852,355.00) inclusive of applicable taxes;

WHEREAS, a Pre-Bid Conference was held on April 23, 2024 with four (4) prospective bidders in attendance, namely;

1. B-Shine Pharma
2. Belmed Enterprise, Inc.
3. King Ken B. Industries Holdings, Inc.
4. Flexi-Pharma

WHEREAS, the BAC issued a supplemental bid bulletin to change the Approved ABC posted in PhilGEPs from PhP 852,355.00 to PhP 851,355.00;

WHEREAS, during the scheduled date for the selling of Bid Documents on April 26-May 4, 2024, One (1) interested bidder availed the official bidding documents in the amount of One Thousand Pesos Only (PhP 1,000.00), namely;

1. B-Shine Pharma

WHEREAS, One (1) bidder submitted a bid proposal within the deadline set on May 6, 2024 at 5pm, namely;

1. B-Shine Pharma

WHEREAS, during the bid opening held last May 7, 2024, the BAC reviewed the eligibility, technical and financial envelopes of each prospective bidders using the "pass/fail" criteria as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184, with the following results;

NOW, THEREFORE, the foregoing premises considered, WE, the Members of ISAT U Bids and Awards Committee (BAC), hereby RESOLVE, as it is hereby RESOLVED:

- a. To declare that B-SHINE PHARMA as the Single Calculated and Responsive Bid (SCRB) for the PROCUREMENT OF MEDICAL SUPPLIES FOR MEDICAL CLINIC and awarded the contract in the total amount of Seven Hundred Ninety Thousand Five Hundred Forty Five Pesos and Fifty Centavos Only (Php 790,545.50) inclusive of applicable taxes; and
- b. To recommend for approval of the University President the foregoing findings.
