A RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO NIG MARKETING CORPORATION FOR THE PROCUREMENT OF TELEVISION FOR CIT-EPA Project Reference No. ISAT U GOODS 2025-01-004

WHEREAS, during the scheduled date for the selling of Bid Documents on October 18-28,2024, Three (3) interested bidders availed the official bidding documents in the amount of One Thousand Pesos Only (PhP 1,000.00), namely;
